#### PRECAUTIONARY MEASURES FOR EXTRAORDINARY GENERAL MEETING

In light of the epidemic situation of novel coronavirus disease (COVID-19), the following precautionary measures will be implemented at the EGM to safeguard the health and safety of Members who might be attending the EGM in person:

- i. Compulsory body temperature checks will be conducted for every attendee at the entrance of the EGM venue. Any person with a body temperature of over 37.4 degree Celsius may be denied entry into the EGM venue and be required to leave the EGM venue.
- ii. Every attendee will be required to wear a surgical face mask throughout the EGM and inside the EGM venue, and to sit at a distance from other attendees. Please note that no masks will be provided at the meeting venue and attendees should bring and wear their own masks.
- iii. No refreshment will be served.
- iv. Each attendee may be asked whether
  - (a) he/she has travelled outside of Hong Kong within the 14-day period immediately before the EGM;
  - (b) he/she is subject to any HKSAR Government prescribed quarantine; and
  - (c) he/she has any flu-like symptoms or close contact with any person under quarantine or with recent travel history. Anyone who responds positively to any of these questions may be denied entry into the EGM venue and be required to leave the EGM venue.

In addition, the Association reminds all Members that physical attendance in person at the EGM is not necessary for the purpose of exercising voting rights. Members may consider appointing the chairman of the EGM as their proxy to vote on the relevant resolution(s) at the EGM instead of attending the EGM in person, by completing and return the form of proxy enclosed with this circular.

# PROPOSED CHANGE OF ASSOCIATION NAME AND NOTICE OF EXTRAORDINARY GENERAL MEETING

# **INTRODUCTION**

Reference is made to the letter from the Sports Federation & Olympic Committee of Hong Kong, China (SF&OC) dated 28 December 2022 regarding Use of Use of "Hong Kong, China" in the Association Name.

The purpose of this circular is to provide you with (i) information on the Proposed Name Change and (ii) the notice of the EGM at which a special resolution will be proposed to approved the Proposed Name Change.

#### PROPOSED CHANGE OF ASSOCIATON NAME

The Board proposes to change the English name of the Association from "The Hong Kong Baseball Association Limited" to "The Baseball Association of Hong Kong, China Limited", and the dual foreign name in Chinese of the Association from "香港棒球總會有限公司" to "中國香港棒球總會有限公司".

#### CONDITIONS FOR THE PROPOSED NAME CHANGE

The Proposed Name Change is subject to satisfaction of the following conditions:

- (i) the passing of a special resolution by the Members at the EGM approving the Proposed Name Change
- (ii) the Companies Registry of the HKSAR Government approving the Proposed Name Change by issuing a certificate of incorporation on change of name

Subject to the satisfaction of the conditions set out above, the Proposed Name Change will take effect on the date of entry of the new English and Chinese names of the Association on the register maintained by the Companies Registry of the HKSAR Government. The Companies Registry of the HKSAR Government will issue a certificate of incorporation on change of name thereafter. The Association will carry out the necessary registration and/or filing procedures with the Companies Registry of the HKSAR Government.

# **REASONS FOR THE PROPOSED NAME CHANGE**

With reference in the letter from the Sports Federation & Olympic Committee of Hong Kong, China (SF&OC) dated 28 December 2022 regarding Use of Use of "Hong Kong, China" in the Association Name.

Following the return of sovereignty of Hong Kong on 1 July 1997, the SF&OC (then known as "Amateur Sports Federation & Olympic Committee of Hong Kong") signed an agreement with the International Olympic Committee on 3 July 1997 to adopt the name "Sports Federation & Olympic Committee of Hong Kong, China". The agreement also confirmed the use of the Regional Flag, the Chinese National Anthem and a new emblem to represent Hong Kong, China Teams on official occasions.

The above steps were taken in compliance with the Basic Law, which specifies the use of the name "Hong Kong, China" in dealings with international organizations, in Article 149 as follows:

"Non-governmental organizations in fields such as education, science, technology, culture, art, sports, the professions, medicine and health, labour, social welfare and social work as well as religious organizations in the Hong Kong Special Administrative Region may maintain and develop relations with their counterparts in foreign countries and regions and with relevant international organizations. They may, as required, use the name "Hong Kong, China" in the relevant activities."

Recently we conducted a stocktaking exercise and found that only a small proportion of our Member Associations have added the words "Hong Kong, China" to their names.

If the Member Associations will continue to represent Hong Kong in international sports competitions / activities, they are required to include the words "Hong Kong, China" (「中國香港」 in Chinese) in the Association name. The Member Associations are also reminded to use the name "Hong Kong, China" when participating in any international sports competitions / activities and to display it on uniforms, websites and all other publicity materials, where applicable.

These changes should be completed before 1st July 2023.

#### **EFFECTS OF THE PROPOSED NAME CHANGE**

The Proposed Name Change will not affect any rights of the Members. Once the Proposed Name Change becomes effective, a digital membership card of the Association will be published on the Association's Online Registration System under the new name of the Association. All existing certificates of participation/completion/appreciation in issue bearing the present name of the Association will, after the Proposed Name Change becoming effective, continue to be evidence of title to such qualifications/recognition.

There will not be any arrangement for exchange of the existing certificates of participation/completion/appreciation for new certificates bearing the new name of the Association. Subject to the confirmation of the SF&OC, the English and Chinese short names of the Association and a new logo for branding of the Association in the sports sector will also be changed after the new association name becomes effective.

Further announcement(s) will be made as and when appropriate in relation to, among other things, the results of the EGM, the effective date of the Proposed Name Change and the new English short name and Chinese short name and a new logo for branding of the Association in the sports sector.

The form of proxy shall be prescribed by the Association from time to time and be dispatched to the Full Members together with the notice of the General Meeting. Unless a poll is so demanded, a declaration by the chairman of the General Meeting that a resolution has, on a show of hands, been carried, or carried unanimously

or by a particular majority, or lost, and an entry to that effect in the book of the proceedings of the Association, shall be conclusive evidence of that fact, without proof of the number of votes recorded in favour of or against that resolution.
