#### ANNOUNCEMENT OF COMPANY NAME CHANGE AND ADOPTION OF NEW COMPANY LOGO

With reference to the letter dated 28 December 2022 from the Sports Federation & Olympic Committee of Hong Kong, China (SF&OC) regarding the use of "Hong Kong, China" in the Association Name.

Following the return of sovereignty of Hong Kong on 1 July 1997, the SF&OC (then known as "Amateur Sports Federation & Olympic Committee of Hong Kong") signed an agreement with the International Olympic Committee on 3 July 1997 to adopt the name "Sports Federation & Olympic Committee of Hong Kong, China". The agreement also confirmed the use of the Regional Flag, the Chinese National Anthem and a new emblem to represent Hong Kong, China Teams on official occasions.

The above steps were taken in compliance with the Basic Law, which specifies the use of the name "Hong Kong, China" in dealings with international organizations, in Article 149 as follows:

"Non-governmental organizations in fields such as education, science, technology, culture, art, sports, the professions, medicine and health, labour, social welfare and social work as well as religious organizations in the Hong Kong Special Administrative Region may maintain and develop relations with their counterparts in foreign countries and regions and with relevant international organizations. They may, as required, use the name "Hong Kong, China" in the relevant activities."

If the Member Associations of SF&OC will continue to represent Hong Kong in international sports competitions / activities, they are required to include the words "Hong Kong, China" (「中國香港」in Chinese) in the Association name. The Member Associations are also reminded to use the name "Hong Kong, China" when participating in any international sports competitions / activities and to display it on uniforms, websites and all other publicity materials, where applicable.

The Hong Kong Baseball Association Limited held its extraordinary general meeting at Meeting Rooms 4-5, 1st Floor, Olympic House, 1 Stadium Path, Causeway Bay, Hong Kong on Friday, 17 February 2023 at 3 p.m. to pass the special resolution:


